Biographie :

Bernardo Vitta is a CONICET doctoral fellow and researcher at the Ambrosio L. Gioja Institute for Legal and Social Research (Faculty of Law, University of Buenos Aires, Argentina). His work sits at the intersection of legal philosophy, critical theory, and Law & Literature, with a particular focus on performativity, aesthetics, and the right to freedom of expression. Drawing on Derrida, Butler, Rancière, and Benjamin, his research explores how legal regimes of speech shape—and can be disrupted by—aesthetic practices and forms of public appearance. He has undertaken research stays in Spain (Universidad Carlos III de Madrid; University of Valladolid; University of Málaga) and in the United Kingdom (University of Westminster). In parallel with his academic work, he co-directs an independent performance space in Buenos Aires (Sala de Máquinas), which informs his methodological interest in practice-based and performative approaches to law.
